- The school provides Title I parents with an explanation of the curriculum used at the school, the assessments used to measure student progress, and the proficiency levels students are expected to meet.
 - Quarterly parent meetings provide detailed information and explanations of curriculum, assessments, and proficiency levels, ELPAC results, and report cards.
 - o Bi-annual School Site Council Meetings provide a forum to review school wide progress by grade level and student groups.
 - Yearly parent conferences, and conferences upon request, provide detailed feedback on student progress, proficiency levels, and assessment data.
- If requested by Title I parents, the school provides opportunities for regular meetings that allow the parents to participate in decisions relating to the education of their children.
 - Parents can request meetings with the principals, and members of the Student Study Team to answer questions, make decisions, and develop goals
 - o Parent emails and contacts are responded to within 24 hours
 - O Administrators and School Psychologist will meet with parents and teachers during Student Study Team (SST) meetings to discuss achievement of students

 Parent workshops will be provided for parents specifically focused on understanding the Common Core State Standards, Smarter Balanced Assessments, and Common Core Aligned Report Cards.

- The school will provide Title 1 parents with materials and training to help them work with their children to approve their children's achievement.
 - AFCS has previously purchased Raz Kids, Achieve3000, Math-whizz, Reading Eggs to provide enrichment materials parents can use at home with their children.
 - Teachers develop work packets for parents to use in supporting their children academically during breaks.
 - Parents are provided for the support social-emotional development of their child through support of school psychologist.
- With the assistance of Title 1 parents, the school educates staff members about the value of parent contributions, and in how to work with parents as equal partners.
 - Parent concerns are addressed by members of the Parent Support Team, school administrators, and classroom teachers.
 - Parent concerns and issues are discussed with staff during meetings and conferences.
- The school coordinates and integrates the Title 1 Parent Involvement Program with other programs, and conducts activities such as Quarterly Parent Meetings, and English Learner Advisory Committee Meetings to encourage and support parents in more fully participating in the education of their children.
 - o Parent workshops on specific topics have been provided
 - o English Learner Advisory Committee Meetings
 - Parents are encouraged to volunteer in their child's classroom, on field trips, and during school wide events.
- The school distributes information related to school and parent programs, meetings, and other activities to Title 1 parents in a format and language that the parents can understand.
 - Multiple languages are represented at America's Finest Charter School. In an attempt to communicate more effectively with parents speaking a language other than English, we establish key communicators from the school community to provide written translation services for important information about school and at parent meetings.
 - Parent requests in alignment with our school wide mission and vision are considered. Requests are granted based on maximum impact, fiscal feasibility, and capacity building.
