All families are invited to both sets of meetings as well as inviting parents/families to Parent/Teacher conferences which will occur twice this year.

The rights and responsibilities of parents and families involved with Title 1 will be a constant discussion topic at all meetings.

Recent surveys show that a meeting at 5:30 meets the needs of most of our families who are willing to participate in school meetings. The school will continue to monitor when our Title One families will best be served. Child care will be offered to families throughout the year to encourage attendance and home visits are completed when students are falling behind, have poor attendance or there is a concern.

Parents and families will have access to this data at any time they request such information.
